New Election Laws effective for November 3 General Election

Early Voting

No-excuse, early voting for everyone begins on September 18, 45 days before Election Day, at the Courthouse. All excuses previously required for a voter to be eligible to vote in-person or by mail using an absentee ballot are <u>eliminated</u>. No-excuse, early voting is available regular business hours Monday through Friday at the Courthouse starting September 18. In addition, on the two Saturdays before Election Day, you may vote early at the Courthouse.

Deadline for returning absentee ballot

In the 2020 Virginia Presidential Primary, 67,565 (5.63% - largest percentage of any state) votes were rejected for arriving late. The new law states that as long as the postmark or other indication of mailing or sending the ballot via commercial delivery service indicates the ballot was mailed by Election Day, the ballot can still be counted if received by the General Registrar by noon on the third day after the election.

Election Day is state holiday

This bill removes Lee-Jackson Day, which was the 3rd Monday in January from the list of legal holidays and adds Election Day, the Tuesday immediately following the first Monday in November.

Voter Identification; repeal of photo identification requirements

The new Voter ID law removes the requirement that voters show a form of identification containing a <u>photograph</u> in order to be allowed to vote. The bill requires a voter to show either their voter registration confirmation documents, their valid Virginia driver's license, their valid United States passport, or any other identification issued by the Commonwealth, one of its political subdivisions, or the United States; any valid student identification card issued by any institution of higher education located in the Commonwealth or any private school located in the Commonwealth; any valid student identification card issued by any institution of higher education located in any other state or territory of the United States; any valid employee identification card containing a photograph of the voter and issued by an employer of the voter in the ordinary course of the employer's business; or a copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows the name and address of the voter.

A voter who does not show one of the required forms of identification when offering to vote is required to sign a statement that they are the named registered voter they claim to be in order to be permitted to cast a ballot.


